- I.- To amend with immediate and general effect, Rule 20(2)(a) of the Rules of Procedure of the States of Deliberation by inserting at the end of the words in that sub-paragraph: “, save that in elections for the offices of Deputy Chief Minister, Minister and Chairman the Greffier shall publish a list detailing the vote cast by each Member of the States, as soon as possible after the conclusion of the Meeting of the States convened for the election of Members of Departments and Committees during May 2012 and quadrennially thereafter in accordance with Rule 7(1) of the Rules governing the Constitution and Operation of States Departments and Committees; and thereafter to” and to elect Deputy Gavin A St Pier as Minister for the Treasury and Resources Department to serve until May 2016 in accordance with Rule 7 of the Constitution and Operation of States Departments and Committees.
