**MOTION OF NO CONFIDENCE IN THE MINISTER AND MEMBERS OF  
THE HEALTH AND SOCIAL SERVICES DEPARTMENT**

I.- Her Majesty's Deputy Greffier having laid the Motion of No Confidence in the Minister and Members of the Health and Social Services Department dated 7<sup>th</sup> December, 2012, signed by Deputy M. P. J. Hadley and seven other Members of the States, and the Presiding Officer having advised the States that Deputy A. H. Adam had tendered to him his resignation from the office of Minister of the Health and Social Services Department, pursuant to Rule 7(3) of the Rules relating to the Constitution and Operation of States Departments and Committees, and the Presiding Officer having further advised the States that Deputies B. L. Brehaut, E. G. Bebb, D. A. Inglis and A. M. Wilkie had tendered to the Minister of the Health and Social Services Department their resignations from the office of Member of the Health and Social Services Department, pursuant to Rule 7(7) of the Rules relating to the Constitution and Operation of States Departments and Committees, and Article II having been debated and voted upon:-

1. That the proposition that pursuant to Rule 18 of the Rules of Procedure, the States of Deliberation have no confidence in the Minister and Members of the Health and Social Services Department be withdrawn.
2. To elect:
  - (1) Deputy M. H. Dorey as Minister of the Health and Social Services Department to complete the unexpired portion of the term of office of Deputy A.H Adam;
  - (2) Deputies B. L. Brehaut, E. G. Bebb, S. A. James M.B.E. and M. J. Storey as members of Health and Social Services Department to complete the unexpired portions of the terms of office of Deputies B. L. Brehaut; E. G. Bebb; D. A. Inglis and A. M. Wilkie

to serve until May 2016 in accordance with Rule 7 of the Constitution and Operation of States Departments and Committees.

- II.- After consideration of the Report dated 6<sup>th</sup> December, 2012, of the Health and Social Services Department, to delegate authority to the Treasury and Resources Department to increase the 2012 revenue expenditure budget of the Health and Social Services Department by a maximum of £2,500,000 and to rescind resolution 1 of Billet d'État XXVI of 12 December 2012 and to authorise the Treasury and Resources Department to transfer from the Contingency Reserve (Tax Strategy) to General Revenue a maximum sum of £32,000,000 during 2012.
