- 1. To delete Propositions 1 to 3 and to substitute therefor:
  - "1. To approve the replacement of States funding for Elizabeth College, The Ladies' College and Blanchelande College by way of a General Grant and full fees payment for Special Placeholders with a new lump sum Bursary Grant to be paid each year for seven years from 1 September 2012 as set out in Option 5 in Appendix One to this Report.
  - 2. To direct the Education Department in collaboration with the Colleges to develop award criteria by which each College would grant stepped level bursaries according to a weighted set of criteria based on academic attainment through the 11+ examination system and the ability to pay assessed via a means test as set out in Option 5 in Appendix One to this Report.
  - 3. To approve the principle that, adopting a Bursary Grant along the lines set out in Option 5 in Appendix One to this Report, the amount of States funding for the Colleges will reduce by £1 million/annum (2011 values) by year seven of the agreement (ie. 2018).".
- 2. To insert a further proposition as follows:
  - "8. To approve the principle that Elizabeth College, The Ladies' College and Blanchelande College play an important role in the island's education system.".
