11. EXPLANATORY NOTE

This purpose of this amendment is to correct some internal cross-referencing in the original propositions, to add a proposition required to give effect to a recommendation in the update to the Social Policy Plan and to expand the propositions without affecting their substance and then re-order them in such a way that they might, if the States so wishes, be debated as a series of discrete topics in accordance with the sub-headings that have been inserted. For the sake of simplicity, the amendment replaces in their entirety the propositions on pages 1370-1371 of the Billet d'État.

In particular, this amendment: -

- 1. Separates the original propositions that combined references to two or three of the Policy Plans into distinct propositions relating to each Plan in turn;
- 2. Corrects the cross-referencing to section numbers in original propositions 1, 2 and 5,
- 3. Inserts an additional proposition (numbered 4) formally to rescind the extant Resolution in respect of repeating the Survey of Guernsey Living Standards. Resolution 6 on Article VII of Billet d'État XXV of 2003 states: "to direct the States Advisory and Finance Committee to commission a repeat survey of Guernsey Living Standards early in 2009 and to report back to the States on the findings." Repeating the Survey had to be deferred as a consequence of the unsuccessful bid for funding for it in the 2009 SSP process. This has meant that the Policy Council's Social Policy Group has not had the funding to carry out such a study and it is recommended that the resolution be rescinded to remove the requirement placed on the Policy Council by the 2003 resolution. Instead the Social Policy Group would like to carry out alternative in house research on minimum income standards, as included in the Social Policy Plan.

EXPLANATORY NOTE

It is stated at page 1170 of the States Report that the first macroeconomic and fiscal objective of the States is "long-run fiscal balance: spending within constraints of the Fiscal Framework".

On Billet d'État No. XI of 2009, the States of Deliberation resolved that the overarching objective of the Fiscal Policy Framework should be to "achieve the economic position of long-run permanent balance, i.e. that income and expenditure should match over the medium term to ensure continued conservative fiscal policies of the States of Guernsey".

The States of Deliberation further resolved that in order to ensure adherence to the Fiscal Policy Framework, there would be an undertaking that "...measures to counter identified structural deficits are agreed within two years of their identification."

This amendment is proposed to ensure that the 'balanced budget' policy objective of the Fiscal and Economic Policy Plan and the Fiscal Policy Framework is fulfilled in a way which is prudent and responsible.

To insert at the end of the words in Proposition 6: ", but subject to the modification that, in relation to Outcome 3 of the Environmental Policy Plan as previously approved, the words "healthier than" shall be substituted for "at least as healthy as"".

Explanatory Note

The long run vision of the Environmental Policy Plan in part is to protect and enhance the quality of the environment we live in. The Plan establishes a list of desired outcomes which show improvements over the long term (p1229) whether in terms of education and information (6), green house gases (10), energy use (13), biodiversity (15/16), building standards (19), air pollution (22), ground water quality (23) or solid and liquid waste disposal (24). As a result of these initiatives, Guernsey's environment in 2030 should be healthier than in 2008, and a commitment to that outcome should be made in the list of Plan Outcomes.

To direct the Public Services Department and Environment Department, when strategy formulating the new waste and revising management/disposal plan in accordance with actions to be taken to deliver the Environmental Policy Plan, to adopt as their starting point all the principles of the Waste Hierarchy, as developed from the provisions of Directive 2008/98/EC of the European Parliament and of the Council of 19 November 2008 on waste and repealing certain Directives (the revised EU Waste Framework Directive), for the purpose of identifying the best waste management options for Guernsey.".

Explanatory Note

The purpose of this amendment is to give to the Public Services and Environment Departments a formal direction to use the Waste Hierarchy as the general guiding principles which lays down a priority order of what constitutes the best overall environmental option in waste legislation and policy and measures should be taken to encourage the options that deliver the best overall environmental outcome. These principles include waste disposal as set out in Resolution 4 on Article 14 of Billet d'État No. IV of 2010 (arising from the amendment moved by Deputy Lowe). The principles of the Waste Hierarchy are now widely used elsewhere for informing waste strategies. Further, the misdescription in the Environmental Policy Plan at pages 1231 and 1234 (the "Best Practical Environmental Option" (BPEO)) implies that the BPEO is wrongly being regarded as a necessary consequence of the wording of the Environmental Pollution (Guernsey) Law, 2004, use of the BPEO methodology not being a legal requirement.

In accordance with its activity to 'develop and implement strategies designed to maintain, defend and enhance Guernsey's standing within the global community' described in the Policy Council's operational plan summary at page 1254 of that Report, to direct the Policy Council, having had regard to the island's fiscal and economic forecasts, to report to the States of Deliberation by no later than September, 2011 with proposals to set a long-term funding policy to underpin Guernsey's contribution to overseas aid and development, which report shall include an analysis of the feasibility of meeting the United Nations target of contributing 0.7% of Gross National Income (or Gross National Product) annually.".

EXPLANATORY NOTE

In 2002, at the United Nations International Conference on Financing for Development, held in Monterrey, Mexico, agreement was reached on what has become known as the Monterrey Consensus, which included a commitment that jurisdictions in the developed world would aim to spend annually on overseas aid and development sums equivalent to 0.7% of their Gross National Income (or Gross National Product).

This commitment was reiterated in 2008 at the International Conference on Financing for Development, held in Doha, Qatar to review the implementation of the Monterrey Consensus. What has become known as the Doha Declaration included the following: "We urge those developed countries that have not yet done so to make additional concrete efforts towards the target of 0.7% of GNP...to developing countries..."

In 2009, the States of Deliberation agreed to a statement of overarching objectives, which included:

- Maintenance and enhancement of Guernsey's standing in the global community; and
- Improved awareness of the culture and identity of Guernsey.

This amendment contends that these objectives may remain unfulfilled unless Guernsey gives serious consideration to committing to the internationally-accepted targets for overseas aid and development set out in the aforementioned Monterrey Consensus and Doha Declaration. The amendment proposes that at the very least this area of policy should be subject to an informed debate in the States of Deliberation about the establishment of a credible rationale to underpin annual contributions to aid and development overseas.

To direct the Policy Council to report to the States as soon as practicable and, in any event, by May 2011 setting out clarification of precisely what is meant by the term 'efficiency saving' in the context of the Financial Transformation Programme and proposals for a revised policy to provide for spending on prioritised New Service Developments to take effect from 2012 to be funded only from efficiency savings already realised rather than predicted efficiency savings."

Explanatory Note

The first purpose of this amendment is to reverse the previous decisions of the States that the <u>predicted</u> savings from what is now the Financial Transformation Programme shall be used when considering the funding available for prioritised service developments. The second purpose is to require the Policy Council to bring forward its review of the funding policy only in relation to actual and proven efficiency savings and separately from the SSP process to enable consideration of that new policy before the States are asked to make decisions on funding such developments in relation to 2012 and thereafter.

Resolutions 3 and 4 on Billet d'État No. XXVI of 2009 state as follows:-

- "3. That all of the savings from the Fundamental Spending Review (FSR) in the first three years (i.e. 2010–2012 inclusive) of the programme shall be made available to fund prioritised service developments through the States Strategic Plan process.
- 4. That, as a general principle, the States will only fund new service initiatives in any of the first three years of the programme (i.e. 2010–2012 inclusive) up to the full value of the FSR savings predicted for the relevant year; and that thereafter this policy will be reviewed as part of the ongoing SSP process."

"H. Funding part of revenue consequences of transferring States Housing into Alderney Housing Association (£100,000)."

Explanatory Note

Alderney's States Housing is in the same position as Guernsey's was some years ago. In order to achieve balanced States of Alderney budgets, insufficient funds have been spent on repairs and maintenance of the States' housing stock. Gross rents currently exceed expenditure on States housing by around £165,000 per annum. The situation is further exacerbated by the fact that Alderney does not operate a housing rebate regime, nor participate in Guernsey's scheme, and overall rents are lower.

In order to address this problem, a new, entirely separate legal entity, the Alderney Housing Association Ltd, has been formed which will be run by the Guernsey Housing Association under a framework agreement. Nearly all of the States' housing stock will be transferred into this new company. Consequently, in future all rents will be received, and operating expenses will be met, by the Association.

The financial consequence of this new arrangement is that it will leave a deficit of £165,000 in the States of Alderney budget. The purpose of this amendment is therefore to fund, in part only, that deficit.

EXPLANATORY NOTE

For information, in its bid for funding of the bowel cancer screening programme, the Health and Social Services Department states that the cost in year one would be £200,000, reducing to £190,000 annually thereafter.

It should be noted that this amendment proposes deleting a new service development which would cost £250,000 per year and substituting one which would cost £200,000 in year one and £190,000 per year thereafter. But the amendment purposely desists from attempting to allocate the remaining £50-60,000 per year, the distribution of which is a matter for the Policy Council, the Treasury and Resources Department and, ultimately, the States of Deliberation to consider separately to the proposal above.

Explanatory Note

The purpose of this amendment is to divert half of what is proposed for improving the storage of museum objects towards conducting the one-off review of terms and conditions of all States staff (see page 1164 of the Report, showing this expenditure is only needed for 2011). The most important asset of the States is frequently described as being "its people". The proposed review of terms and conditions is designed to produce a long-lasting benefit for a lot of people for comparatively little expense, whereas the improvement of storage of museum objects is a much longer-term project that would still be capable of being started in 2011.

The proposed survey will achieve a means of setting base rate levels of family expenditure, so as to enable all of the departments involved in the disbursements of benefits and allowances, (in whatever form) to set those respective benefits and allowances at a level that reflects actual base levels. This amendment will only be moved if the amendment moved by Deputy Fallaize to substitute the initiative lettered "K" in original Proposition 4 is successful.
