- 1. To approve the timing of the recommended programme for capital projects within the approved Capital Programme (as per the Gantt chart in Section 7 of that Report).
- 2. To note that the Treasury and Resources Department will closely monitor the balance in the Capital Reserve and that any variations from the recommended programme could result in the recommendation to delay future projects.
- 3. To note that the delay in the recapitalisation of Cabernet Limited will lead to a requirement to extend guarantees currently given by the States and authorise the Treasury and Resources Department to enter into such arrangements as necessary.
- 4. To instruct that all Departments submitting proposals for States of Deliberation approval of transfers from the Capital Reserve must:
 - a. include in those proposals good quality and sufficient information on the capital project, to enable a decision to be made corporately, such information to include a business case, a risk assessment, full costings following a tender process, and details on management of the project; and
 - b. follow the procedures adopted by the States of Guernsey with regard to capital projects and as outlined in the Codes of Practice.

SOCIAL SECURITY DEPARTMENT

BENEFIT AND CONTRIBUTION RATES FOR 2010

XIII.- After consideration of the Report dated 31st July, 2009, of the Social Security Department:-

- 1. That, with effect from 4th January 2010, the standard rates of pension and contributory social insurance benefits shall be increased to the rates set out in paragraph 19 of that Report.
- 2. That, with effect from 1st January 2010, for employed persons, the upper weekly earnings limit, the upper monthly earnings limit and the annual upper earnings limit shall be £1,536, £6,656 and £79,872 respectively.
- 3. That, with effect from 1st January 2010, for employers, the upper weekly earnings limit, the upper monthly earnings limit and the annual upper earnings limit shall be £2,259, £9,789 and £117,468 respectively.
- 4. That, with effect from 1st January 2010, for employed persons and employers, the lower weekly earnings limit and the lower monthly earnings limit shall be £114 and £494 respectively.
- 5. That, with effect from 1st January 2010, for self-employed persons, the upper earnings limit and lower earnings limit shall be £79,872 per year and £5,928 per year, respectively.
- 6. That, with effect from 1st January 2010, for non-employed persons the upper and

- lower annual income limits shall be £79,872 per year and £14,820 per year respectively.
- 7. That, with effect from 1st January 2010, the allowance on income for non-employed people shall be £6,290 per year.
- 8. That, with effect from 1st January 2010, the voluntary contribution shall be £16.24 per week for non-employed people.
- 9. That, with effect from 1st January 2010, the overseas voluntary contribution shall be £77.26 per week for non-employed people and £85.40 for self-employed people.
- 10. That the apportionment of contribution income for employed and self-employed persons and non-employed persons over 65 shall be as set out in paragraphs 49 and 50 of that Report.
- 11. That, with effect from 1st January 2010, the prescription charge per item of pharmaceutical benefit shall be £2.90;
- 12. That, the Health Service (Benefit) Guernsey Law, 2002 be amended:
 - (a) to allow monies to be paid from the Fund towards the cost of research and development activities, including pilot programmes;
 - (b) to allow the actuarial review of the Guernsey Health Service fund to be undertaken by an actuary appointed by the Department;
- 13. That, with effect from 4th January 2010, the contribution (co-payment) required to be made by the claimant of care benefit, under the long-term care insurance scheme, shall be £165.62 per week.
- 14. That, with effect from 4th January 2010, nursing care benefit shall be a maximum of £685.44 per week for persons resident in a nursing home or the Guernsey Cheshire Home and residential care benefit shall be a maximum of £367.15 per week for persons resident in a residential home.
- 15. That, with effect from 4th January 2010, respite care benefit shall be a maximum of £851.06 per week for persons receiving respite care in a nursing home or the Guernsey Cheshire Home and a maximum of £532.77 per week for persons receiving respite care in a residential home.
- 16. That, with effect from 8th January 2010, the supplementary benefit requirement rates shall be as set out in paragraph 92 of that Report.
- 17. That the Supplementary Benefit Law 1971 (as amended) and the (Classes of persons to whom the Law applies) Ordinance, 2005 be further amended on the

lines set out in paragraphs 96 to 103 of that Report.

- 18. That, with effect from 8th January 2010, the weekly benefit limitations for supplementary benefit shall be:
 - (a) £395 for a person living in the community;
 - (b) £463 for a person who is residing in a residential home; and
 - (c) £664 for a person who is residing as a patient in a hospital, nursing home or the Guernsey Cheshire Home;
- 19. That a supplementary fuel allowance of £22.70 per week be paid to supplementary beneficiaries who are householders from 23rd October 2009 to 23rd April 2010.
- 20. That, with effect from 4th January 2010, the rates of attendance allowance and invalid care allowance and the annual income limits shall be as set out in paragraph 121 of that Report.
- 21. To direct the preparation of such legislation as may be necessary to give effect to their above decisions.

VI.- TO POSTPONE CONSIDERATION of this Article to the October meeting of the States.

TREASURY AND RESOURCES DEPARTMENT

AMENDMENTS TO THE INCOME TAX (GUERNSEY) LAW, 1975

VII.- After consideration of the Report dated 14th July, 2009, of the Treasury and Resources Department:-

- 1. To revise the Income Tax Law to transfer the benefit of income tax relief in respect of donations to charity from the donor to the recipient (subject to a de minimis contribution of £500 per annum, per charity, by each donor) and to increase the limit of donations that each individual may make and which would qualify for relief to £5,000 (£10,000 for married couples) (with transitional provisions for donations under deeds of covenant entered into prior to 1 January 2010) as set out in paragraph 2.
- 2. To revise the Income Tax Law to provide that where a company writes off a loan this would not constitute a taxable distribution to the extent that the loan was taxed when it was originally advanced, as set out in paragraph 3.
- 3. To permit the "flow through" of overseas tax suffered by a company, to the beneficial member when the relevant income is distributed or deemed as distributed to the beneficial member, for the purposes of unilateral relief, with effect from 1 January 2008, as set out in paragraph 4.
- 4. To transfer the responsibility for the hearing of income tax appeals from the Treasury and Resources Department to the Guernsey Tax Tribunal, as set out in paragraph 5.

- 5. To give power to the Policy Council to make Regulations, as it sees fit, concerning the formal procedure and administration of income tax appeals (including provisions relating to the costs of an appeal), as set out in paragraph 5.
- 6. To provide for the appointment of a Deputy Clerk to the Guernsey Tax Tribunal and to permit the deferral of notification of a delay appeal, to the Tribunal, until such time as the Director of Income Tax or the appellant so require, as set out in paragraph 5.
- 7. To repeal the taxation provisions relating to certain payments made by the Social Security Department which have become outdated with the passage of time, as set out in paragraph 6.
- 8. To make certain changes to the regime for the taxation of individuals who are resident but not solely or principally resident for income tax purposes, as set out in paragraph 7.
- 9. To extend the definition of "partnership" in the Income Tax Law to include limited liability partnerships (and to introduce a definition of "limited liability partnership" accordingly), as set out in paragraph 8.
- 10. To repeal the present restriction on an exempt body holding shares in a Guernsey company, which itself is not exempt (with appropriate provisions to ensure that such companies having income taxable at 10% or 20% would continue to pay tax, at those rates, on relevant sources of income), as set out in paragraph 9.
- 11. To replace the date of 30 June 2009 with the date 31 December 2009, in respect of an election for 2008 onwards for the purposes of the exemption from the deemed distribution regime, for company profits, and to provide that an election may be treated as revocable where there has been a transfer of control of a company, as set out in paragraph 10.
- 12. To provide for an anti-avoidance provision, in connection with the rules for the limiting of the liability of individuals, as set out in paragraph 11, and to provide that the tax credit which may attach to a distribution made by a company, of its profits which arose prior to 2008, is not repayable.
- 13. To approve, under section 81A(5) of the Law, the Income Tax (Guernsey) (Employees Tax Instalment Scheme) (Amendment) (No 2) Regulations, 2009, as set out in paragraph 12 and appended to this Report.
- 14. To direct the consolidation of the Income Tax Law, as set out in paragraph 13.
- 15. To direct the preparation of such legislation as may be necessary to give effect to their above decisions.

 - Resurfacing of the aprons
 - Resurfacing and realignment of the taxiways
 - Replacement of the airfield ground lighting system and relocation of navigational aids
 - Improvements to foul and surface water drainage
 - Minor miscellaneous items, e.g. foundations for security huts, security fencing, etc.
 - Contingency sums, fees etc.
- 3. To approve the following list of contractors to be invited to tender:
