<u>1 - Purpose</u>

The purpose of this Guernsey Advisory Circular is to make public the opening hours and contact details for inspecting the registers maintained by the Aircraft Registrar.

2 - Related laws and regulations

This Guernsey Advisory Circular relates to:

- The Aviation Registry (Guernsey) Law, 2013, sections 10(1) and 10(6); and
- The Aviation Registry (Fees) Regulation 2013.

<u> 3 - Definitions</u>

Definitions, in the context of this GAC shall have the meanings listed in GAR Part 1 (Definitions, Abbreviations and Units of Measurement).

4 - The Registers

The following registers are available for inspection by the public:

- The Aircraft Register;
- The Engine Register;
- The Charges Register.

5 - Days and hours for public inspection

The registers maintained by the Aircraft Registrar pursuant to section 10 (1) of the law referred to in section 2 above, are open for public inspection during normal weekdays from 10:00 to 16:00 hours. By prior telephone arrangements, another time for inspection may be arranged.

7 - Location

The offices of the Aircraft Registrar and of the Channel Islands Aircraft Register are co-located at the following location:

8 - Copies or extracts of entries in the Registers.

Upon request, copies or extracts of entries in the Registers will be supplied certified or uncertified.

For a certified copy or extract a fee applies, as published by Commerce and Employment Department in the Aviation Registry (Fees) Regulation 2013.
