NOTES

1. A fee of £110 will be charged to purchase a non-special mark. This fee **INCLUDES** the assignment fee, meaning that there would be no further charge to allocate the mark to a vehicle.
2. It is Driver & Vehicle Licensing's (DVL) policy to charge a fee of £55 when an existing mark is assigned to a vehicle that is being registered for the first time in Guernsey, whether this existing mark comes from an exchange or a BDE (Broken up/Destroyed or Exported vehicle).
3. The fee of £110 allows a person to hold an existing mark for their future use. This **INCLUDES** the subsequent assignment fee, meaning that there is no further charge when the person wishes to have the mark assigned to a vehicle within the one-year retention period.
4. To extend the right to a retained mark, a further fee of £110 is payable to hold the mark for a maximum of one further year. This extension is at DVL's discretion. The application to extend the retention must be made within the last 28 days of the original retention period.
5. If you choose to retain the registration mark for future use, it will be retained in the name of the current registered keeper of the vehicle. The keeper will be issued with a Certificate of Retention for the registration mark. Once a registration mark is retained, it is **non-transferrable**, meaning that the registration mark can only be allocated to a vehicle registered in the same name.
