Under The Motor Taxation (First Registration Duty) (Guernsey) Ordinance 2016, as amended, motor tax based on a vehicle's carbon dioxide emissions shall be charged and paid upon the first registration of a motor vehicle in Guernsey. You must complete this form if your vehicle falls into one of the classes or uses of motor vehicle which is eligible for exemption from First Registration Duty or is entitled to a preferential rate.
