



## APPLICATION TO REGISTER A MOTOR VEHICLE EXEMPTIONS AND PREFERENTIAL RATES

Under The Motor Taxation (First Registration Duty) (Guernsey) Ordinance 2016, as amended, motor tax based on a vehicle's carbon dioxide emissions shall be charged and paid upon the first registration of a motor vehicle in Guernsey. You must complete this form if your vehicle falls into one of the classes or uses of motor vehicle which is eligible for exemption from First Registration Duty or is entitled to a preferential rate.

Please note that if these conditions are not met, you shall no longer be entitled to the preferential rate, and must pay the balance of the full amount of the First Registration Duty within 30 days of the date of re-importation of the vehicle to Guernsey.*
