- 3. The vessel must be insured as a commercial fishing vessel and a copy of the certificate for the vessel detailed in this application must be submitted.
- 4. A copy of your right to work document.

- 1. Vessels Registered in Guernsey, Alderney and Sark, with the Port Letter and Number (PLN) prefixed GU, must have an economic or residential link to the Bailiwick Islands.
- 2. The licence is not transferable to any other vessel and applies only to the vessel which the applicant has detailed in this application
- 3. The licensee must be the sole operator of the vessel and the vessel and licence cannot be chartered or leased.
