

ORDINANCES LAID BEFORE THE STATES

THE CÔTE D'IVOIRE (RESTRICTIVE MEASURES) (GUERNSEY) (REPEAL) ORDINANCE, 2016

In pursuance of the provisions of the proviso to Article 66A(1) of The Reform (Guernsey) Law, 1948, as amended, "The Côte d'Ivoire (Restrictive Measures) (Guernsey) (Repeal) Ordinance, 2016", made by the Policy & Resources Committee on the 2nd August, 2016, is laid before the States.

EXPLANATORY MEMORANDUM

This Ordinance repeals the Côte d'Ivoire (Restrictive Measures) (Guernsey) Ordinance, 2015 ("the 2015 Ordinance"). The 2015 Ordinance gave effect to EU Regulations 174/2005 and 560/2005, which were enacted to implement certain United Nations measures which imposed both restrictions on the provision of assistance to the Cote d'Ivoire in respect of military activities and targeted financial restrictions applicable to listed persons. Earlier this year the United Nations measures were lifted, following the continued positive evolution of the situation in Côte d'Ivoire, including the successful conclusion of the presidential elections last year. The 2015 Ordinance is therefore no longer required.

The Ordinance was made by the Policy & Resources Committee in exercise of its powers under Article 66A(1) of the Reform (Guernsey) Law, 1948, and came into force on the 2nd August, 2016. Under the proviso to Article 66A(1) of the Reform (Guernsey) Law, 1948, the States of Deliberation have the power to annul the Ordinance.

THE PROTECTION OF INVESTORS (ADMINISTRATION AND INTERVENTION) (BAILIWICK OF GUERNSEY) (AMENDMENT) ORDINANCE, 2016

In pursuance of the provisions of the proviso to Article 66A(1) of The Reform (Guernsey) Law, 1948, as amended, "The Protection of Investors (Administration and Intervention) (Bailiwick of Guernsey) (Amendment) Ordinance, 2016", made by the Policy & Resources Committee on the 25th July, 2016, is laid before the States.

EXPLANATORY MEMORANDUM

This Ordinance amends the Protection of Investors (Administration and Intervention) (Bailiwick of Guernsey) Ordinance, 2008 ("the 2008 Ordinance"), to remove any doubt as to the application of provisions of the Companies (Guernsey) Law, 2008 ("the 2008 Law"), relating to protected cell companies. This Ordinance will ensure that the powers of the Court to give directions to administrators under the 2008 Ordinance are, except where express provision to the contrary is made by any enactment, subject to the provisions of Part XXVII of the 2008 Law, thus removing doubt which has recently arisen as to the overriding principle laid down by those provisions of the ring-fencing of the assets of protected cells.

The Ordinance was made by the Policy & Resources Committee in exercise of its powers under Article 66A(1) of the Reform (Guernsey) Law, 1948, and came into force on the 25th July, 2016. Under the proviso to Article 66A(1) of the Reform (Guernsey) Law, 1948, the States of Deliberation have the power to annul the Ordinance.

STATUTORY INSTRUMENTS LAID BEFORE THE STATES

The States of Deliberation have the power to annul the Statutory Instruments detailed below.

THE SALLES PUBLIQUES (FEES FOR RENEWAL OF LICENCES) REGULATIONS, 2016

In pursuance of sections 1 and 5 of the Fees, Charges and Penalties (Guernsey) Law, 2007 made by the Environment Department on 29th April, 2016, are laid before the States.

EXPLANATORY NOTE

The Regulations increase the fee payable to HM Greffier on renewal of a salle publique licence.

The Regulations came into force on 1st June, 2016.

THE LAND PLANNING AND DEVELOPMENT (IMMUNITY CERTIFICATE FEE) REGULATIONS, 2016

In pursuance of sections 3(3)(b) of the Land Planning and Development (Enforcement) Ordinance, 2007 and section 89 of the Land Planning and Development (Guernsey) Law, 2005, made by the Environment Department on 12th April, 2016, are laid before the States.

EXPLANATORY NOTE

The Regulations repeal and replace the Land Planning and Development (Immunity Certificate Fee) Regulations, 2009.

The main difference from the 2009 Regulations is that they substitute a fee of £70 for the previous £50 fee to cover increased costs related to the issuing of immunity certificates since 2009. The new fee will apply to applications for immunity certificates made on or after 3rd May, 2016.

The Regulations came into force on 3rd May, 2016.
