To add a further proposition as follows:

## "3. To direct –

- (a) the States Trading Supervisory Board in consultation with the Committee for Economic Development, by no later than 31<sup>st</sup> January, 2017 to identify and indicate to the Development & Planning Authority and the Committee for the Environment & Infrastructure a suitable area or areas of land consisting of at least 4 acres owned, or the occupation of which is controlled, by the States (such as the Belgrave Vinery site or part of that site) that could be used for light industrial use if suitable amendments were made to Guernsey's planning regime, and
- (b) the Development & Planning Authority and the Committee for the Environment & Infrastructure, by no later than 30<sup>th</sup> April, 2017, to submit proposals for consideration by the States which would enable, or potentially enable, the area or areas of land identified and indicated further to paragraph (a) of this Proposition to be used for planning purposes for light industrial use.".
