SURVEY RESULTS



SUMMARY OF RESULTS

- 1,055 people responded to the Survey, with 865 completing all the required questions.
- Perception of knowledge of the Criminal Justice system has increased by about 10% since 2013 (figure 2.1), although understanding of how to access information remains the same (figure 2.4).
- Compared to 2012, confidence in the Criminal Justice System (total answers of 'very' and 'fairly' confident) is lower in all categories considered (figure 2.5).
- As in 2013, the top three perceived causes of Crime in the Bailiwick are alcohol, lack of discipline from parents and drugs (figure 3.1).
- The majority of respondents were not worried or not very worried about being a victim of crime (74%) (figure 3.4).
- The two areas which caused most concern overall were 'being subjected to a fraud' or scam and 'vandalism/criminal damage'. The same pattern was observed in 2013 (figure 3.5).
- Compared with the 2013 survey, the percentage of respondents answering 'no' to being involved in the use of illegal drugs has increased by 20% (figure 3.7).
- The percentage dissatisfaction with drug services on the Island is high (figure 3.9), however the sample size in this area is very small and the survey was not directly promoted towards the users of these services, a further more targeted survey would be required to understand whether there are any real problems in this area.
- Overall 70.91% of respondents perceived domestic abuse as a problem in Guernsey (figure 3.10), when divided by gender 60% of men answered 'yes' compared to 80% of the female respondents.
- Overall the percentage of respondents selecting that they were of each community sentence type was higher than 2013, with increased knowledge in each category (figure 4.1).

- The majority of people would be interested in participating in restorative justice (52.4%) (figure 5.1).
- As in 2013, the majority of respondents would like the support of the Victim Support & Witness Service (figure 6.1).
- Over 50% of respondents who had been a victim or witness to a crime had not been made aware of the service (figure 6.4).
- Satisfaction with the Victim Support & Witness Service remains very high with 77.78% of respondents either satisfied or very satisfied (83% in 2013) (figure 6.6).

1. RESPONDENT PROFILE

Number of Respondents

The 2015 Survey received a total of 1,055 respondents, with 865 people answering the full Survey. Within a population the size of Guernsey's, this sample size is sufficient to provide a margin of error of 3 at a confidence level of 95%, i.e. if 40% of the sample pick an answer we can be 95% sure that the true percentage of the population that would pick that answer would be between 37% and 43%. Some more specific questions had a much smaller response rate; response rate is provided alongside each figure.

Age of Respondents

The age profile of the survey respondents was fairly reflective of the Island's population, although the representation of under 16s and over 61s was relatively low; the Survey, however, was not designed to be answered by under 16s and the reliance on social media as a means of promotion may have caused the relatively few older respondents.



The Survey had almost equal representation of male and female respondents.






Birthplace and Local Identity

The majority of respondents were born in the Channel Islands and 90% of the respondents considered themselves to be local to Guernsey. The question 'Do you consider yourself to be local?' was added to the 2015 Survey in order to explore whether there was a difference in perception resulting from an individual's apparent relationship to the Island.

2. THE CRIMINAL JUSTICE SYSTEM

This section asked about how much respondents felt they knew about the Criminal Justice System, whether they would be able to access information in relation to it and how confident they were about its effectiveness.

Knowledge and Awareness

How much do you know about the work of the Bailiwick of Guernsey Criminal Justice System?




Overall those answering 'a lot' or 'a fair amount' to this question was 10% greater than the same in question in 2013 (50.95% as opposed to 40% in 2013), however perceived knowledge was still relatively low with about 50% of respondents reporting that they had 'not very much' knowledge or knew 'nothing at all' about the Island's Criminal Justice System. Self-reported knowledge amongst male respondents was greater than females and the knowledge of individuals who did not identify themselves as local was greater than those that did (although this is likely due to the smaller sample size of the 'non-local' respondents and their apparent interest in the subject matter).

These are the organisations that make up the Bailiwick of Guernsey Criminal Justice System. How much do you know about the following?



Only the Police and GBA had reported knowledge levels of over 50% 'a lot' or 'a fair amount' answers, whilst reported knowledge of the other organisations was relatively low. The level and pattern of awareness between organisations remains the same as the 2013 Survey results.


Do you know how to access information relating to the Criminal Justice System?



The majority of respondents were unaware of the potential means to access information about Guernsey's Criminal Justice System. Performance in this area is very similar to that in 2013 where the percentage of respondents answering 'no' was 59.9% and 'yes' 40.10%.

A confidence level of above 50% is apparent for all categories other than 'deals with cases promptly and efficiently'. Compared to 2012, confidence in the Criminal Justice System (total answers of 'very' and 'fairly' confident) is lower in all categories, as shown in the table below (fig. 2.7).

3. CRIME & LAW ENFORCEMENT

This section examined people's experiences of crime in the Bailiwick of Guernsey, specifically focusing on what people considered to be a major cause of crime and how the level of crime has changed since the last survey. Two areas of crime are considered in more detail; illegal drugs and domestic abuse.

What do you consider to be a major cause of crime in the Bailiwick of Guernsey?





As in 2013, the top three perceived causes of Crime in the Bailiwick are alcohol, lack of discipline from parents and drugs.



Although the pattern of crime perception is the same as in 2013, the percentage of 'a lot more crime' answers has increased by 8.58% since the 2013 Survey. There is no significant difference in perception between male and female respondents.




The majority of respondents were not very worried about being a victim of crime. The pattern of concern is the same as that expressed in 2012 where 56.2% of respondents answered that they were 'not very worried' about being a victim of crime. There is no significant difference in perception between male and female respondents.



The two areas which caused most concern overall were 'being subjected to a fraud' or scam and 'vandalism/criminal damage'. The same pattern was observed in 2013. Concern expressed was higher amongst female than male respondents, particularly in relation to sexual assault.


CRIME & LAW ENFORCEMENT: ILLEGAL DRUGS

Over the past two years, have you been involved in the use of illegal drugs?




Compared with the 2013 survey, the percentage of respondents answering 'no' to being involved in the use of illegal drugs has increased by 20%. The percentage of males answering yes is 10% greater than females.

Cannabis remains the most popular answer for 'what type of illegal drug?' with over 90% of respondents selecting it (61% in 2013). The percentage answering 'don't know' has fallen considerably from 35% to 4%. The percentages for former legal highs, prescription drugs and heroin have fallen, whilst ecstasy has increased.

This questioned was introduced in 2015 in order to establish some performance feedback in relation to the drug support services in the Island. Percentage dissatisfied is high for each service however the sample size is very small and the survey was not directly promoted towards the users of these services, a further more targeted survey would be required to understand whether there are problems in this area.

Do you view domestic abuse to be a problem locally?



In your opinion is domestic abuse...




4. SENTENCING


These questions focused on what happens after someone is found guilty of committing a crime and what factors should be taken into account when sentencing.

When someone is found guilty of an offence in the Bailiwick of Guernsey, there are a number of community sentences available. Which of the below have you heard of before now?





Since 2013, the percentage of respondents selecting 'rehabilitation' has increased (53.5% to 65.8%) and to act as a deterrent has also increased (53.4% to 62.3%). The level of response for the other options remains the same.



What provisions do you think should be available for prisoners?







As in 2013, the most popular responses were education/training, drug and alcohol treatment, offending behaviour programmes, counselling services and unpaid work. Telephones in cells and work off the prison site were added to the 2015 survey.

5. RESTORATIVE JUSTICE:

The questions in this section focus on the victim-centred process of Restorative Justice, asking whether people would use the service if they were to be a victim of crime.

If you were the victim of a crime would you like the opportunity to communicate with the person who was responsible and express how you had been affected?



The response pattern to this question was almost identical to 2013. In both years the majority of people answered yes (52.4% in 2015, 51% in 2013).

Conflict often occurs between individuals, especially in neighbourhoods and other communities. Should this be your experience in the place you live, would you be interested in being involved in a process for dealing with the conflict where those affected can gather together for a structured conversation to transform the situation?



Would you be in supportive of the use of restorative practice within schools? a process that favours relationship over retribution




If you did choose to access the service, what support would you like?







If you have used the Victim Support & Witness Service, how satisfied were you with the service you received?



Satisfaction with the Victim Support & Witness Service remains very high with 77.78% of respondents either satisfied or very satisfied (83% in 2013).
