

## NOTICE OF WITHDRAWAL (POISONOUS SUBSTANCE)

Under the Poisonous Substances (Guernsey) Law, 1994, and Regulation 11(8) of the Control of Poisonous Substances (Guernsey) Regulations, 2014, as amended, the approval of the products containing the active ingredients named below is hereby revoked. This revocation of approval will take effect on the relevant dates shown for the different authorised activities.

### Notes

- The importation, sale and supply of the product is prohibited after 30 June 2017.
- Use and storage by the final user is prohibited after 30 June 2018.
- Products which are no longer approved should be returned to the supplier or disposed of via the States of Guernsey hazardous waste collection and disposal service.
- Continuing to import, sell, supply, store or use after the due dates is an offence and could lead to further action.
- Other products containing glyphosate, but not POE-tallowamines are not concerned by this notice and remain approved in Guernsey.
