## **Employment Permit Reconversion**

If an employee has left your employment within 28-days for Short-term Permit and 6-months for Medium/Long-term Permits, you may be able to complete a reconversion to save you from having to complete and pay for a brand new application. Please note there is and administration cost of £30 for the reconversion.

Always check who you are "Working as" before applying for anything.


