

List of Licenced and Prohibited Pesticides in Guernsey – April 2020

Licenced Pesticides

The following active ingredients have UK approval but can only be used under licence in Guernsey as they are considered a higher risk to people or the environment. The table below shows the products currently approved in the UK (April 2020).

Metaldehyde	Numerous	Numerous	Slugs & Snails	The initial ban on the use of metaldehyde in the UK was overturned but expected to be sought again. In Guernsey the ban remains and a licence is required to use any products containing it.
Oxamyl	Vydate 10G	16595	Root nematodes, stem & bulb nematode, Bemisia tabaci, Lyriomyza leaf miners.	Current UK approval for use on outdoor carrot (& protected carrot), fodder beet, parsnip (& protected parsnip), potato, sugar beet. EAMU's for Outdoor ornamental plant production & Bulb onion, garlic and shallot.
Bendiocarb	FICAM D (1.25% powder)	BPR 2018-1136	Asian hornets and wasps	Approved as a biocide / insecticide against Asian hornet nests (indoor and outdoor use for SoG Asian Hornet Team only) and wasp nests (indoors use) in Guernsey. Must not be used on crops and food products.
Bendiocarb	FICAM W (80% w/w wettable powder)	HSE 5390	Ants, fleas and bedbugs.	Approved as a biocide / insecticide against ants, fleas and bed bugs infestations indoors only. Must not be used on crops or food products. (NB. FICAM W is being withdrawn in the EU - end of use 10/12/2020).

EAMUs* (Extension of Approval for Minor Use) are at the Growers risk and can only be used under the conditions and rates specified in the EAMU and on the product label

Licencing of Products Approved in & Imported from EU / EEA Countries

Under certain circumstances products approved in EU / EEA countries can also be considered for licencing. The product would need to be approved for the intended use in an EU country already. The following are examples which would be considered on that basis.

Pyridaben	Aseptacarex	Red spider mite, Whitefly	Must be approved for intended crop in EU country of approval
Imidacloprid		Vine weevil, general pest control.	Approval in UK withdrawn in 2018 but still has EU approval for use as insecticide, in permanent greenhouses or for the treatment of seeds intended to be used only in permanent greenhouses. The resulting crop must stay within a permanent greenhouse during its entire life cycle.

Approved UK Pesticides but Prohibited in Guernsey

All products containing **Aluminium Phosphide, Aminopyralid, Picloram, Chlorpyrifos or Chlorpyrifos–methyl** are banned in Guernsey as they are considered to pose and unacceptably high risk to people or the wider environment.

The table below shows those products currently approved in the UK (April 2020) but prohibited in Guernsey.
