## Parent/Carer Out of Catchment Area/Partner Site (PC-OCAPS) Request Form

It is recognised that in certain situations parents/carers may have valid reason for requesting their child attends a school other than the one in the catchment area in which the parent or carer resides or, for children moving from Year 6 to Year 7, other than the Secondary Partner Site for the child's current primary school.

If parents/carers wish to request a placement in a school outside their catchment area or other than their secondary partner site they will need to demonstrate why it would be unreasonably detrimental to the child's education to attend the allocated school. These are referred to as PC-OCAPS (Parent/Carer Out of Catchment Area/Partner Site) request; information on the circumstances within which such requests may be agreed is available at www.gov.gg/schooladmissions.

The completed form, along with any additional information a parent/carer may wish to include must be returned to the Student Finance and Admissions Manager at the address above. The PC-OCAPS Request Form may be submitted either in writing or by email.
