BROCK UNIVERSITY UNDERGRADUATE SCHOLARSHIP - 2024 ENTRY

Information Sheet for Applicants

Brock University in Canada is offering one Scholarship to a person ordinarily resident in Guernsey, Alderney or Herm wishing to pursue an undergraduate course commencing in the autumn term of 2024. The University will meet the tuition fees of the Scholarship holder.

Persons wishing to apply for a Scholarship should make an application to Student Finance, who will forward all applications to Brock University. Student Finance may interview applicants if the University wishes to have a recommendation from it.

Courses and Course Information

Brock University offers a variety of first degree courses. Most courses leading to honours degrees are four years in duration.

Persons who need guidance as to whether their qualifications will be acceptable to Brock University may contact the university for advice before applying for the Scholarship.

Financial Support

The University Scholarship will cover the cost of the tuition fees.

Student Finance will award a travel grant to cover the cost of up to two return fares per year for an undergraduate scholar.

Assistance towards the student's living and other travelling costs is available through the Higher Education Awards Scheme and will be subject to the normal income assessment.

Applications for the Scholarship

Student Finance invites applications for the 2024 Undergraduate Scholarship. The successful applicant will have demonstrated a high level of academic accomplishment and a genuine interest in participating fully in the student life of the University.

Applications will be considered from students who have yet to take A Levels or another post 16 qualification, as well as from persons who already have such qualifications.

Application for deferred entry is not possible on this occasion.

If you wish to apply for the Undergraduate Scholarship, you should supply the following documents:

- 1. A completed form *Brock University Guernsey Scholarship Application for Admission to Undergraduate Studies* obtainable from Student Finance.
- 2. A letter addressed to the Director of Education explaining why you wish to study your chosen subject at Brock University;
- 3. An academic transcript (i.e. a statement of your educational qualifications signed by the head of your educational institution); and
- 4. A reference from the head of your educational institution.

N.B. – Items 3 and 4 should be supplied as separate original documents (not photocopies).

All the documents should be sent to the **Student Finance**, **Level 4**, **Sir Charles Frossard House**, **La Charroterie**, **St. Peter Port**, **Guernsey**, **GY1 1FH**, in a sealed envelope. Please mark the outside of the envelope **'Brock University Undergraduate Scholarship Application'**.

Applications for the Undergraduate Scholarship should reach Student Finance by 31st December 2023.

Please note that, if you are successful in securing the scholarship, you will need to maintain a minimum level of grades to ensure the scholarship is carried forward in the future years of the course.
