**Request:**

Can you provide a list of all MoU's States committees have signed with a) Jersey b) Sark c) Alderney and d) the UK since 2012?

Can you provide a copy of these and any monitoring reports or evidence of their impact?

**Response from the Policy & Resources Committee:**

1. Agreement of Decentralised Cooperation between Région Basse-Normandie, La Manche, the Government of Jersey and the States of Guernsey and as Associate Signatories, the States of Alderney and Chief Pleas of Sark (signed in Cherbourg-Octeville on 22 January 2015)
2. Agreement of Decentralised Cooperation between Région Normandie, La Manche, the Government of Jersey and the States of Guernsey and as Associate Signatories, the States of Alderney and Chief Pleas of Sark (signed in Jersey on 16 September 2016) (this agreement supersedes the one signed in 2015 as in 2016 it was resigned with the newly formed region of Normandy, following changes to the French regions on 1 January 2016 which combined Haute-Normandie and Basse-Normandie – the previous agreement was with Basse-Normandie)
3. Partnership agreement 2017-2019 on cooperation between the Department of Ille-et-Vilaine, the Government of Jersey and the States of Guernsey (signed in La Guesnière, 12 June 2017)
