ADDITIONAL REPAIRS - an <u>additional</u> repairs allowance (known as "excess repairs allowance") may be available for the costs of repairing, maintaining, insuring and managing any let property. If a claim is to be made you should submit a schedule of the expenditure incurred, for each property separately (evidence of expenditure may be requested). Any allowance due (this is calculated by averaging expenditure over a five year period) will be calculated by Revenue Service.
