PROPOSED POSTPONEMENT OF THE JUNE 2020 GENERAL ELECTION

#### **AMENDMENT**

Proposed By: Deputy J S Merrett Seconded By: Deputy E A McSwiggan

- 1. In Proposition 2, to delete "30<sup>th</sup> June, 2021" and substitute therefor "30<sup>th</sup> April, 2021".
- 2. In Proposition 3, to delete "16<sup>th</sup> June, 2021" and substitute therefor "21<sup>st</sup> April, 2021".

#### **EXPLANATORY NOTE**

This amendment reflects the request of a number of States Members, who cannot support either the original propositions nor (in full) the proposal to defer the Election until June 2021, that an alternative (Spring 2021) date for the General Election should be proposed.

For reference: the Easter Bank Holiday takes place on  $2^{nd} - 5^{th}$  April, 2021 and the school Easter holidays from  $1^{st} - 19^{th}$  April, 2021.
