Explanatory Note

The Development & Planning Authority (D&PA) believes it should be party to the discussions on the Recovery Strategy in response to the Covid 19 crisis as they believe Guernsey should be building its way out of the crisis. The D&PA also believes the debate by the States on the D&PA's inclusion in the membership of any committee set up whether to agree or only advise on the Recovery Strategy should properly be taken

at the time the proposals for such a committee were brought back to the States by the Policy & Resources Committee. However, having noted the submission of the Dorey/Ferbrache Amendment which specifically addresses the membership of the proposed replacement committee, this Amendment will be laid if that amendment is successful in order for the States to debate whether the D&PA should be a member. A supporting report under Rule 24(1) is attached itemising the areas of the D&PA's mandate which are relevant to the economic recovery and which cross over with the mandates of other Committees. The D&PA believes this indicates the need for the D&PA to be present from the start of dialogue on such matters to enable effective cross-government work enabling agreed outcomes to aid recovery.
