3. Details of workshops held between October 21st 2020 and February 8th 202, either remotely (because of covid-19 safety protocols) or in person with stakeholders as part of the Committee's work on the Future of Secondary Education.

While the request picks the date of 21st October, for context it is important to clarify that this date was in the middle of a planned six-week period of extensive consultation with Secondary school staff via a series of workshops. These workshops began on 5th October and concluded on 16th November. The consultation included three workshops at each of the four secondary schools examining different priorities for the future of Secondary and post-16 education, with another three workshops involving the combined Senior Leadership Teams of the four Secondary schools. There was also a round of introductory sessions run at each school week commencing 28th September 2020. All sessions were run by an independent facilitator.

However, in terms of the specific dates requested:

- 21st October, workshop at St Sampson’s High
- 22nd October, workshop at Les Beaucamps
- 3rd November, combined Senior Leadership Team workshop
- 9th November, workshop at St Sampson’s High
- 10th November, workshop at Les Beaucamps High
- 11th November, workshop at La Mare de Carteret High
- 12th November, workshop at Grammar School and Sixth Form Centre
- 16th November, combined Senior Leadership Team workshop

The island went in to lockdown on 23rd January 2021 which has understandably impacted the Committee’s ability for further face-to-face engagement with key stakeholder groups.
