Bailiwick of Guernsey

Interim authorisation to ensure continuity of access to Bailiwick waters for French fishing vessels from 23:00 on 31st December 2020 – under The European Union (Sea Fisheries, etc.) (Brexit) (Bailiwick of Guernsey) Regulations, 2020



31st December 2020 – Edited in September 2021 to reflect a further one-month extension to 31st October 2021

Introduction

The Bailiwick of Guernsey has agreed to the application of the relevant provisions of the Trade and Cooperation Agreement between the United Kingdom and the European Union (TCA).

The Committee *for* Economic Development, on behalf of the Bailiwick authorities, has ensured that access for French fishing vessels in Bailiwick waters is permitted from 23:00 on 31st December 2020 on the terms agreed and set out in the TCA.

This has been achieved through an interim authorisation, initially for a period of 3 months until 31st March 2021, in order to allow time to develop a full licensing scheme for eligible French fishing vessels.

The European Commission has since requested more time to resolve the last remaining technical issues before the new regime can be brought into force. Consequently, this interim authorisation has been extended on a monthly basis. It has since become necessary to extend it by a further month, until 31st October 2021.

The full licensing scheme is currently being developed and will be in place at the earliest opportunity. Details of the licensing scheme will be published in due course.

The purpose of the scheme will be to provide certainty and stability for French fishing vessels, so as to allow them to fish sustainably within Bailiwick waters, in accordance with the TCA.

Interim authorisation

From 23:00 on 31st December 2020, until 31st October 2021, the French fishing vessels listed below may fish in accordance with the conditions set out below.

For the avoidance of doubt:

- any French fishing vessel which is not listed below is not authorised to fish in Bailiwick waters, and
- any French fishing vessel listed below fishing in Bailiwick waters must fish in accordance with the conditions set out below.



The list of French fishing vessels that are authorised to continue fishing in Bailiwick waters during this interim period is based on a list provided by the French authorities.

Please note that, given the timescales, the Committee will not issue interim authorisations to individual vessels. This statement and the list below provide the necessary authorisation.

The issue of an interim authorisation by Guernsey does not remove any requirement imposed by the French Republic or the European Union on a French fishing vessel before it may fish in Bailiwick waters.

French fishing vessels listed below may use this interim authorisation as part of an application for a valid fishing authorisation to the French Republic for the purposes of the SMEFF Regulation (EU Regulation 2017/2403 on the sustainable management of external fishing fleets).

Conditions

- 1. Eligible French fishing vessels may fish in the authorised zone for demersal species and crabs.
- 2. No dredging is allowed in the authorised zone outside of the Sark Box.
- 3. All vessels of 15 metres and over in length overall are required to be fitted with Automatic Identification System (AIS) and continually transmit the vessel's position whilst present within Bailiwick waters, in accordance with Council Regulation (EC) No 1224/2009.

For the purposes of these conditions -

- (a) the "authorised zone" means the area of territorial sea lying seaward of 6 nautical miles from the baselines from which the breadth of the territorial sea adjacent to the Bailiwick of Guernsey is measured between the designated line clockwise to a demarcation line drawn north-east from Alderney Lighthouse,
- (b) the "designated line" means the series of straight lines joining, in the sequence given, Points 1 to 13 indicated in Schedule 3 to the Territorial Sea Act 1987, as extended by the Territorial Sea Act 1987 (Guernsey) Order 2019, as those points relate to the area of territorial sea lying seaward of six nautical miles, and
- (c) "demersal species" means all sea fish other than salmon, migratory trout, mackerel, clupeoid fishes, sand eels, Norway pout, smelts, eels, great weevers, crustaceans and molluscs (other than squids).



(d) "Sark Box" means the area of territorial sea lying seaward of 6 nautical miles from the baselines from which the breadth of the territorial sea adjacent to the Bailiwick of Guernsey is measured between the designated line clockwise to a demarcation line drawn south-west of the l'etac de Sark.

Important Information

These arrangements are an interim measure until 31st October 2021.

They do not confer or recognise any additional fishing rights for French vessels, their masters or their owners in Bailiwick waters. They do not provide any expectation that French vessels, their masters or their owners will be permitted to fish in Bailiwick waters after 31st October 2021.

Any fishing between 23:00 on 31st December 2020 and 31st October 2021 will not count towards a track record period for any purpose, particularly the purposes of the forthcoming licensing scheme.

It is the Bailiwick's intention to keep this arrangement in place for the duration of this period provided that good faith continues to be observed on both sides.
