<p style="text-align: center;">1</p> <p style="text-align: center;">Apply for UK catch certificate from Fish Export Service</p>	<p style="text-align: center;">This step is for Fisher Person [Person/s responsible for fishing vessel]</p> <ul style="list-style-type: none">• To create UK IUU documentation, access https://www.gov.uk/guidance/create-a-uk-catch-certificate• You need to register on the Fish Export Service to use it• Upon application you will receive an electronic PDF download. In case of failure, the user will have to reapply or contact the Export Helpline.• You can get documentation 24/7 and there is out of hours support - Fish Export Helpline 0330 159 1989.• Fish Export Service identifies a tariff/CN number for all fish species, presentation and state that require a Catch certificate.• Exporter creates catch certificate when they know what is to be exported. UK CA validates, and issue UK catch certificate. Fisher complete CC section 11 and forward CC to EU CA directly or via importer

This step is for the UK Competent Authority & the Fisher

- The UK CA notify the fisher person that the catch certificate is issued and the fisher person completes section 11 and may then either forwards it on to the EU CA by email or to anyone else designated as an importer (who can complete section 11 and then sends it to the EU CA)
- In order to confirm that the catch has been caught in accordance with appropriate conservation measures, the EU must receive a validated catch certificate - email address for the appropriate EU MS CA can be found on the NEAFC website <https://psc.neafc.org/designated-contacts> (NB this is an IUU requirement but the NEAFC web site provides the contact details)

Instructions for sending forms

Send Forms Here

The prior notification and the pre landing declaration and the catch certificate (as described later in this process) can all be sent at the same time (if they are all in accordance with defined notification times). They should be sent by email from the operator or their representative to the EU Authority as listed on the NEAFC website <https://psc.neafc.org/designated-contacts> (NB this is an IUU issue but the NEAFC website hosts the details). No response (approval) is required as a result of the submission of the prior notification or pre landing declaration prior to landing. <p style="text-align: center;">7 Prior Notification (PNO) message</p>	<p style="text-align: center;">This step is for Fisher Person [Person/s responsible for fishing vessel]</p> <p>Send the PNO message from the e-fishing log /SMS When a fishing vessel wishes to disembark in a French port, it must also carry out the sending of a PNO message at least 4 hours before disembarkation if fishing is fresh, if not 72 hours if frozen fishing. This PNO message must be sent from the electronic fishing log on board the fishing vessel. If the latter does not have an electronic fishing log on board, the elements of the PNO must be sent by SMS (to obtain the available number, you must first call the CNSP). This SMS should contain all the necessary information (the information of the ship, the landing port, the time of landing, the species caught, the weight of each species, the fishing area.</p>

Other Important Information

It is vital that all fishermen ensure that the catch data reported on their pre landing declaration, prior notification, catch certificate, NEAFC port state control form and log book **all match**. Fishers should check carefully when completing the different forms because if they don't match they can't be verified and will be rejected and landing denied.

Direct Landing:

IUU and NEAFC documentation must be received and approved by the French Authorities at the email address below. If the documents are ok they will email you approval to land. You should not attempt to land without approval. It is thought that the French Authorities who authorise landing may only be working normal office hours, we are trying to clarify the situation. We suggest you contact the French Authorities by email to confirm they have received your forms and are able to approve them.

IUU Documents - Catch Certificates, Pre Landing Declaration & Prior Notification Forms

- The UK Fish Export Service 24/7 helpline number is 0330 159 1989 In the first instance contact the helpline number if you encounter any problems with IUU documents. They are dealing with calls from across the UK and Crown Dependencies and may have experience with similar issues.

NEAFC Port State Control (PSC1) Form (and verification)

- The UK FMC (Fisheries Monitoring Centre) number is 0131 244 2286 and email is UKFMC@gov.scot The UK FMC have to verify your NEAFC PSC, if they have not been able to verify your form they may be able to advise why and what you need to do to correct the form.
- Once the UK FMC have completed Part B of the PSC1 form it will be transmitted to the French Authorities. If Part B has been verified they will complete Part C of the PSC1 which is your authorisation to land.
