

Fair Processing Notice

This Fair Processing Notice explains all of the processing of personal data that is being undertaken by the various Committees of the States of Guernsey (“Government”) in response to the Ukraine crisis. Whilst this fair processing notice aims to outline the processes undertaken by the Government as a whole in relation to the Ukraine Sponsor Scheme (USS) and the Ukraine Family Scheme (UFS), the Data Controller responsible for leading this Scheme is the Committee *for* Home Affairs.

The purpose of the scheme is to support individuals who were resident in Ukraine before the start of the War in seeking safe passage to the Bailiwick and staying with either families already resident in the Bailiwick or an approved sponsor.

1. The Data Protection Law

The States of Guernsey acknowledges its obligations as per the Data Protection (Bailiwick of Guernsey) Law, 2017 (‘the Law’) which provides a number of requirements in terms of processing activities involving personal data. The Government further acknowledges the general principles of processing as well as the rights of a data subject and more information in relation to these can be found by visiting www.gov.gg/DP.

2. The Principles of Processing

a. Lawfulness, fairness and transparency

Personal data must be processed lawfully, fairly and in a transparent manner.

The Government acknowledges that all processing must be lawful, fair and must be undertaken with transparency. The tables set out in Appendix A and B explain all of the processing that is being undertaken for the purposes of the Government’s response to the War in Ukraine, the USS and UFS. Furthermore, the table outlines all of the circumstances in which personal data is collected and processed by the Government, the Data Controller responsible for the processing, what that Data Controller is doing with the data and explains the purpose of the processing.

b. Purpose limitation

Personal data must not be collected except for a specific, explicit and legitimate purpose and, once collected, must not be further processed in a manner incompatible with the purpose for which it was collected.

The Government acknowledges its responsibility with regards to this data protection principle and therefore the Government maintains that it will not further process that personal data in a way which is incompatible to its original reason for processing as specified in Appendix A or B, unless the relevant controller is required to do so by law. Personal data will not be transferred to a recipient in an unauthorised jurisdiction (as per the definition within the Law).

c. Minimisation

Personal data processed must be adequate, relevant and limited to what is necessary in relation to the purpose for which it is processed.

The Government maintains that it will only process the personal data which is detailed in Appendix A and B, and will not process any further personal data that is not necessary in relation to the original reason for processing personal data as specified in the relevant Appendix, unless the relevant Controller is required to do so by law.

d. Accuracy

Personal data processed must be accurate, kept up to date (where applicable) and reasonable steps must be taken to ensure that personal data that is inaccurate is erased or corrected without delay.

The Government will ensure that all personal data that it holds and processes for the purposes of this notice is accurate and kept up-to-date, and any personal data that is inaccurate will be erased or corrected without delay.

e. Storage limitation

Personal data must not be kept in a form that permits identification of a data subject for any longer than is necessary for the purpose for which it is processed.

All personal data will be retained by the relevant Controller for as long as is deemed necessary for the purpose for which the data is originally collected and processed. Furthermore, personal data will be erased or kept in a form that does not permit identification of data subjects as soon as the relevant Controller considers that it is no longer necessary to retain that data for those purposes or the purpose of any proceedings or potential proceedings (including any legal proceedings, or complaints to or investigations by the Data Protection Authority).

f. Integrity and confidentiality

Personal data must be processed in a manner that ensures its appropriate security, including protecting it against unauthorised or unlawful processing and against accidental loss, destruction or damage, using appropriate technical or organisational measures.

Personal data will be held in both a hard copy and electronic format. Personal data is protected by the implementation of the Government's information access controls where access to records is tightly controlled. Employees are vetted in a manner commensurate with the role that they are expected to undertake. Protocols are followed to ensure that employees only have access to areas and documents as required to undertake their role; access is monitored and effectively managed.

Secured Premises & Filing – the Government have restricted premises which employees are required to use key cards to access in order to safeguard information from the public. Secure filing cabinets and drawers are also provided for additional storage and security.

g. Accountability

The controller is responsible for, and must be able to demonstrate, compliance with the data protection principles.
