Appendix 2

This certificate relates to the areas of land outlined in yellow and labelled areas 1, 2 and 3, and the area labelled 4a on the attached 1:500 Annotated 2019 Aerial Photograph for Longmeadow, Rue Du Belial, St. Saviour.

Notes

- 1. This certificate is issued solely for the purposes of section 22 of the Land Planning and Development (Guernsey) Law, 2005 ("the Law") and section 3 of the Land Planning and Development (Certificates of Lawful Use) Ordinance, 2019.
- 2. It certifies that the uses specified in Appendix 1 taking place on the land described in Appendix 2 were lawful within the meaning of section 22(3) and (4) of the Law on the date of the application to the Authority for the certificate and, therefore, a compliance notice may not be served in respect of those uses under Part V of the Law on that date.
- 3. This certificate applies only to the extent of the uses described in Appendix 1 and to the land specified in Appendix 2 and identified on the attached plan. Any uses which are materially different from that described or which relate to other land may render the owner or occupier liable to enforcement action.
- 4. This certificate does not certify the lawfulness of any use arising from a material change of use within the meaning of the Building (Guernsey) Regulations, 2012.
- 5. For the avoidance of doubt, as set out above, the issue of a Certificate of Lawful Use relates to the use of the land only, and does not regularise any unauthorised physical development, such as the erection of greenhouses or sheds that would not meet the exemption criteria for householder development nor for the erection of a stable building without the benefit of planning permission.
