

## THE VEHICLE CATEGORIES AND AGE ENTITLEMENTS FOR DRIVING

Please note: MAM = Maximum Authorised Mass – the weight of the motor vehicle or trailer when laden with the heaviest load it is constructed or adapted to carry.

- P Any 2 or 3 wheeled vehicle – engine not exceeding 50cc or electric engine having a maximum continuous rated power not exceeding 4kw.  
14 years.
- A1 Light motorcycle (with or without side-car) max speed over 50km/h OR less than 125cc and power not exceeding 11Kw.  
16 years but one year's experience with full category P required before issue of full A1 licence to applicants under 17.
- A Motor Cycle (with or without side-car) over 125cc.  
17 years but one year's experience with full category A1 required before issue of full A licence to applicants under 18.
- B1 Motor tricycles or quadricycles – max weight (unladen) 550kg (not including battery mass in the case of eclectically propelled); and max speed exceeding 50 km/h OR exceeding 50cc or any other engine of equivalent power.  
17 years.
- B Passenger vehicle/small goods vehicle - maximum authorised mass not exceeding 3500kg and up to 8 seats in addition to driver. Trailer up to 750kg MAM or combination of vehicle and trailer not exceeding 3500kg MAM with trailer MAM not exceeding the unladen mass of the motor vehicle.  
17 years
- C1 Medium goods vehicle - max weight 7500kg MAM and has a minimum authorised mass exceeding 3500kg. Trailer up to 750kg MAM.  
18 years.
- C Large goods vehicle – MAM exceeding 7500kg.  
21 years
- D1 Minibus – up to 16 seats in addition to driver. Trailer up to 750kg MAM.  
18 years
- D Large passenger carrying vehicle. Trailer up to 750kg MAM.  
21 years
- BE See B above - Plus trailer over 750kg MAM  
17 years
- C1E See C1 above - Plus trailer over 750kg MAM up to max weight for combination of 12000kg. Max laden mass of trailer not to exceed unladen mass of the motor vehicle.  
18 years

- CE See C above – Plus trailer over 750kg MAM  
21 years
  
- D1E See D1 above – Plus trailer over 750kg MAM up to max weight for  
combination of 12000kg. Max laden mass of trailer not to exceed unladen  
mass of the motor vehicle and not to be used for the transport of persons.  
18 years
  
- DE See D above - Plus trailer over 750kg MAM  
21 years
  
- F Agricultural tractor - A tractor used primarily for work on land in connection  
with agriculture, horticulture, market gardening and forestry. With or without  
trailer.  
17 years.
  
- G Road repairing machine  
17 years.
  
- L Electrically propelled vehicle (max weight 3500kg)  
17 years.

### **Additional Information**

Passenger Carrying Vehicles – A separate Public Service Vehicle permit must be obtained from the Department before you may drive any passenger-carrying vehicle for public service.
