I have therefore reluctantly come to the decision to tender my resignation as States Deputy and would be grateful if you would place this before the House at the earliest opportunity.

I would mention also that I shall have to convalesce for some months and as only one year of my term of office remains, my continuing membership would be of benefit to no-one, especially the Vale parishioners.

May I conclude by thanking you for your unfailing courtesy, patience and tolerance towards me during the last three years.
