APPOINTMENT OF AN ORDINARY MEMBER OF THE GUERNSEY FINANCIAL SERVICES COMMISSION

Executive Summary

This report proposes the re-election of Advocate Peter Andrew Harwood as an ordinary member of the Commission.

Report

- On 15 December 2005 the States elected, inter alia, Advocate Peter Harwood as Chairman of the Guernsey Financial Services Commission with effect from 2 February 2006. His term of office as a commissioner expires on 1 February 2006. Regrettably no proposition was included within that report to re-elect Advocate Harwood as an ordinary member of the Commission.
- 2. Advocate Harwood was appointed as a commissioner in 2004. He was born in Guernsey and was educated at Elizabeth College and the University of Southampton. Admitted as an English solicitor in 1972 he worked in the City of London until returning to Guernsey in 1981. He was called to the Guernsey Bar in 1982 and has been a partner in the firm of Ozannes since 1983. It is proposed that Advocate Harwood be re-elected for a three-year term commencing on 2 February 2006.

Recommendation

The Policy Council recommends the States to re-elect Advocate Andrew Peter Harwood as an ordinary member of the Guernsey Financial Services Commission for three years from 2 February 2006.
