XIII.- To elect eight sitting Members of the States as members of the Scrutiny Committee to serve until May 2016 in accordance with Rule 7 of the Constitution and Operation of States Departments and Committees.

#### STATES ASSEMBLY AND CONSTITUTION COMMITTEE

#### **MEMBERS**

The States are asked:-

XIV.- To elect four sitting Members of the States as members of the States Assembly and Constitution Committee to serve until May 2016 in accordance with Rule 7 of the Constitution and Operation of States Departments and Committees.

- (NB Paragraphs (1), (1A) and (6) of Rule 20 of the Rules of Procedure of the States of Deliberation provide:
  - "(1) When at any time there are vacancies in two or more of the following offices, the elections to fill those vacancies shall be held in the following order:
    - (a) Chief Minister
    - (b) The Minister of the Treasury and Resources Department
    - (c) The Ministers of the other Departments
    - (d) one of the Ministers as Deputy Chief Minister
    - (e) Chairmen of Committees
    - (f) Members of Departments
    - (g) Members of Committees
    - (h) Chairmen and Members of Non-Governmental Bodies

and the Chief Minister shall determine the order in which the Ministers and Chairmen are elected which same order shall be followed in electing Members of Departments and Committees.

(1A) (a) The Chief Minister shall notify the Greffier not later than 4.00 p.m. on the day (excluding Saturdays, Sundays and Public

Holidays) preceding the meeting of the States convened for the election of Ministers and Chairmen, of –

- (i) the order in which the election of the Ministers and Chairmen is to be held;
- (ii) the names of the candidates whom he intends to propose for the respective offices.
- (b) The Greffier shall forward the information referred to in (a) above to the Presiding Officer and, in electronic format, to every Member who has furnished him with an e-mail address.
- (6) On a proposition to elect members of a Department or Committee the Presiding Officer shall first invite the Minister or Chairman of the Department or Committee concerned, and thereafter other Members, to propose eligible candidates. Nobody shall speak about a candidate at that stage; and if no more candidates are proposed and seconded the Presiding Officer shall put the election of the candidate(s) to the vote without speeches. If there are more candidates than vacancies the Presiding Officer shall invite each proposer to speak, for not more than 5 minutes in respect of each candidate proposed by him, before voting takes place; and neither the candidates nor any other member shall be entitled to speak."

As the Chief Minister will not be elected until 1<sup>st</sup> May, 2012, the elections for Members of Departments and Committees have been listed in alphabetical order. At the States Meeting on 11<sup>th</sup> May, 2012 the Presiding Officer will call the elections for Members of Departments and Committees in the order determined and notified by the Chief Minister pursuant to Rule 20 (1A).)

(NB Elections in respect of Special States Committees and Non-Governmental Bodies will take place at the Meeting of the States of Deliberation to be held on Wednesday, the 30<sup>th</sup> May, 2012.)
