Several errors occurred in the numeration of pages in the 2012 Billets d'État, as follows:

- The pages of Billet d'État I are numbered 2785-2904 rather than commencing at 1. In bound volumes those pages can therefore be found *before* page 1.
- The single page of text in Billet d'État VII and Billet d'État VIII were both numbered 1791. In this index Billet d'État VIII is numbered as 1791(A).
- The pages in Billets d'État XV, XVI, XVII, XVIII and XIX, and also Billet d'État XX up to page 1994 duplicate the numeration of Billets d'État X, XI and XII. In this index the pages of Billets d'État XV, XVI, XVII, XVIII and XIX, and also Billet d'État XX up to page 1994 are given the suffix (A). In bound volumes pages in those Billets d'État with the suffix (A) can be found after Billet d'État XIV.
