# REPLY BY THE MINISTER OF THE HOME DEPARTMENT TO QUESTIONS ASKED PURSUANT TO RULE 6 OF THE RULES OF PROCEDURE BY DEPUTY MARY LOWE

### Question

- 1. In respect of each month during the periods May 2012 December 2012 and January 2013 December 2013 and January 2014 December 2014
  - a) How many flights paid for by the States did the political members of Home Department take?
  - b) To which destinations did the political members of Home Department travel on those flights?
  - c) What were the departure and return dates in respect of each trip from Guernsey

### <u>Answer</u>

Details of flight destinations and departure and return dates can be seen in the attached spreadsheet. Overall, between 01<sup>st</sup> May 2012 and 31<sup>st</sup> December 2014, the number of flights out of the Bailiwick taken by political members of the Home Department paid for by the States totalled 16 (departures and returns treated as separate flights).

2. Which hotels paid for by the States did the political members of Home Department stay and for which nights during 2012 (from May 1 only), 2013 and 2014?

# <u>Answer</u>

The attached spreadsheet illustrates the hotels used by political members and the dates for which they were occupied.

3. What is the total Cost of airfares, hotels and any other expenditure, including any standard day allowances in relation to the out of the Island trips representing the States during 2012 (from May 1 only), 2013 and 2014?
