#### **Explanatory note**

Following consideration of the States Report dated 29<sup>th</sup> August 2007 entitled "Review of Gambling Legislation" included within Billet d'État XXII of 2007 ("**2007 Report**"), the States of Deliberation approved the following recommendation in relation to the introduction of a registration scheme for charitable and not-for-profit bingo ventures only –
