“To delete all propositions and replace therefor:

- To direct the Education Department to submit to the States as soon as practicable a policy letter concerning the future of secondary education in Guernsey as detailed in Appendix 2 of the vision document “Today’s Learners Tomorrow’s World”:
 “We will bring a States Report to the Assembly during 2014 on a new structure for secondary education”*
- To note the Independent Review Panel’s conclusion that “the condition of the school buildings is such that they are no longer suitable”; and to direct the Treasury and Resources Department to liaise with the Education Department to ensure that future annual Budget Reports recommend sufficient funding through annual cash limits and routine capital allocations to ensure that the La Mare de Carteret Schools are adequately maintained until such time as resolutions relating to proposition 1 above are made and carried into effect.”*
