- "3A (1) To note that, in seeking to transform primary education in the manner set out in this Report and as stated in paragraph 6.3, 6.16 6.18 of the Report, there will be various changes to primary school catchment boundaries.
- (2) To agree that those families who will be affected by the immediate extension of the La Mare de Carteret Primary School catchment area (as proposed in Annex 3 of the Report) and have children who will be registered to join reception classes in September 2014, will:
 - i) in the case of those families living in the catchment extension area close to Saumarez Park, be afforded the choice of registering for either La Mare de Carteret Primary School or Castel Primary School; and
 - ii) in the case of those families who currently have a choice (for whatever reason) of registering either for La Mare de Carteret Primary School or Hautes Capelles Primary School, continue to be afforded that choice.
- (3) To agree that those families who have children who will be registered to join reception classes in September 2014 who currently have a choice (for whatever reason) of registering either for Forest Primary School or La Houguette Primary School, will continue to be afforded that choice."
