To add new Propositions 3 and 4 as follows:

- “3. To direct that by no later than December, 2014, and after consultation with other States Departments and other bodies as necessary, the Health and Social Services Department shall lay before the States of Deliberation a States Report or States Reports outlining a clear timetable and the likely costs and funding options for any policy initiatives and material changes to services which in the opinion of the Department it is necessary to introduce during the 2012-16 States Term in order to meet the objectives set out in the 2020 Vision with the financially sustainable model referred to in Proposition 2(i) above.
- “4. To direct that by no later than December, 2015, and after consultation with other States Departments and other bodies as necessary, the Health and Social Services Department shall lay before the States of Deliberation a States Report or States Reports outlining an indicative timetable and indicative costs for any policy initiatives and material changes to services which in the opinion of the Department it is necessary to introduce during the 2016-20 States Term in order to meet the objectives set out in the 2020 Vision with the financially sustainable model referred to in Proposition 2(i) above.”
