Amendment to Billet d'Etat II proposed by Deputy Laurie Queripel

Amendment: To renumber Proposition 21 as Proposition 23 and to insert new Propositions 21 and 22 as follows:

- '21. That the recycling targets approved by the States of Deliberation on 22nd February 2012 (Billet d'Etat No IV) should be interpreted as an expected 'direction of travel' rather than targets which must be achieved.
- '22. To direct that when considering the export of recyclates the Public Services Department shall have regard to the relative costs of export for recycling and export for disposal.'
